Emil Jung's abduction case : Severe complaint against renewed perversion of law in the child-return procedure at Ukraine's Supreme Court on Sept 28 2015

Dear Mr Grechkivsky and colleagues

Hereby I extend my **severe complaints against perversion of law and violation of fundamental rights at Kyiv's Courts of Appeal and Cassation** as submitted to you on Jan 18 2015 and July 20 2015, respectively, in the case of my minor son

Emil Jung, citizen and legal resident of Germany,

born on July 22 2012 and abducted from Munich County to Kyiv since July 10 2013,

to the **Supreme Court of Ukraine** with the judges in charge

W.M.Simonenko, L.I.Okhrimchuk and A.H.Jarema

Reasons:

1. The Supreme Court has **followed the absolutely illegal and law-defying line of the Courts of Appeal and Cassation** as described in detail in both prior complaints (*see attachment I*).
2. The Supreme Court has **completely ignored international law** in the shape of the **Hague Convention on International Child Abduction**.

3. The Supreme Court has **ruled on no legal ground** and conceals its failure behind a sequence of **bizarre, highly evasive and incomprehensible statements** that could have been - or are indeed - copied from the **Soviet era**.
4. The Supreme Court has **not responded at all to my very justified complaints against breach of law and falsification of evidence by the Courts of Appeal and Cassation**. Especially, there was no remark on the fact that these Courts had **brazenly feigned 'the plaintiff's consent to the child's stay in Ukraine'**.

Special remarks:

- A. Ukraine has **ratified the Hague Convention in 2008** - and has **boycotted it ever since**, as parental child abductions from abroad are habitually committed by Ukrainian mothers. **The Higher Courts and the Ministry of Justice are the first and foremost perpetrators of this illegal and inhuman child-abduction policy** (*see attachment II*).
- B. Ukraine is taking an **ever worse international reputation** on its rigid and notorious child-abduction policy, since so many foreign fathers are concerned. The result is an increasing number of **severe complaints to the European Court of Human Rights**. As a matter of public awareness - through media, parliaments and governments -, it is set to **compromise Ukraine's efforts for Western integration**.

Thus - also in the name of all my father-fellows in misery - I ask you

- to **raise your expert voice against the deliberate wrongdoing of the Soviet-minded judges** in charge and to **declare it illegal**

as well as

- to **support a big turn-around** of Ukraine's nasty policy, which encourages endless cross-border child abduction and **directly targets children's welfare**.

Emil is ill-fated with the direct impact of his two-year retention and isolation in Ukraine: He is underdeveloped, pale, thin and skinny, without musculature appropriate to his age.

A Kyiv hospital report recently stated: **asthenic-neurotic syndrom, delayed speech development, flatfeet and lack of vaccination** (*see attachment III*).
